

Below is a list of Traffic Violations with bonds which are preset by the 15<sup>th</sup> Judicial District Court Judges. **Do Not** use the Fine Schedule when setting bonds on Traffic Violations. Those are only to be used when an individual pays for their violation.

D.W.I. (1 <sup>st</sup> Offense)	14:98B	1000.00

D.W.I. (4 <sup>th</sup> or Subsequent Offense)	14:98E	Must Be Set
Driving Under Suspension (DWI)	14:98.3	1000.00

All other Traffic Violations found under Title 14 are set at \$500.00. All Traffic Violations found under Title 32 are to be released with a written citation.

**DO NOT** use the Fine Schedule when setting bonds on Traffic Violations.
