- 2. I have been maced at least three times since I have been detained at the CJC.

Another detainee began to enter and said he was being moved into the unit. He told me he was sick with COVID-19. I told him he could not enter because I did not have COVID-19, and I did not want to be infected.
- 4. I then left my room to go speak with a corrections officer (CO). I found a CO and told them I did not want this cellmate because he had COVID-19. They said they would call a lieutenant. I told them to call their superior. Instead of just a lieutenant, multiple COs and the "SRT" team arrived.
- 5. I told the entire group that I did not want to room with someone with COVID. Then, one of them maced me directly in the face. It was sprayed from a large can.
- 6. The mace burned everywhere. My eyes were burning, and I could barely breathe.
- Then they sprayed three to four of the same large cans, which spread throughout the entire unit. They never gave any warning before macing me or macing the entire unit, 4C.
- 8. The spraying led to unrest among the other detainees, setting off a riot.

- 9. After the unit was locked down, I was finally taken to segregation after about an hour. I used the sink to wash my face. I was able to get some of the mace but the water made it burn worse. After about two weeks of being locked down, I was finally able to get a shower.
- I was never taken to medical besides asking to be taken to medical when I was being moved to segregation.
- 11. The second time I was maced was on or around July 2021 at the CJC in unit 4A.
- 12. The COs and detainees were having words and then a CO began wrestling with a detainee.



I, Leron Harris, #175377, am over the age of 18. I have personal knowledge of the matters herein and am competent to testify regarding these matters. The statements set forth in this declaration are true and correct, to the best of my knowledge and belief. At the time of this declaration, I am detained at the St. Louis City Justice Center (CJC) in 5D.

(1) In January 2021, I got moved back to CJC from MSI. They told me they lost my property. I had been without toothpaste, soap, food, books for weeks. I'm trying to talk to the CO's and said I wouldn't lock down until I got a supervisor to talk to me. It was the only way I had to talk to a supervisor. I was in handcuffs with my hands behind my back.

(2) CO Wilbourn asked me if I was going to lock up. I said yes, but what about my property. He said "I don't have time for this." He then said "you have one more second." I took a couple steps back to try to comply. I guess I wasn't moving fast enough.

(3) He sprayed me with a big black can of bear mace. I think it was 15-20 inches sprayed directly in my eyes.

(4) The sting gripped my face. It felt like I was burning alive. My eyes were burning for 3-4 days. I didn't go to medical. Two days later, after I complained and another officer noticed how my eyes were swollen and red I saw a nurse.

(1) I have been maced three times since December 2020. The first macing incident occurred on or about December 2020 when they were trying to move me to the workhouse. I didn't want to go to the workhouse, so while I was in the common area of unit 4C a male CO maced me with a riot size can of mace 4-5 times. I was maced in my face, chest, and back of my head. They put me in my cell and they had turned the water off until I went to medical about an hour or so later. After I was taken to medical they then moved me to the workhouse. I was there for about 4 months.

(2) The second time I was maced was at the workhouse, in my cell. I had thrown a cup of water out of my chuckhole and a guard claimed I threw it at him. He sprayed mace threw my chuckhole. They didn't let me out for about two hours. I was not taken to medical nor given new clothes. CO Graham was the officer that maced me.

(3) The third macing incident occurred when I was moved back to CJC from the workhouse. I was in unit 4C and they were trying to move me to 5C to have a cellie. One of the detainee uprisings of 2021 had happened and all of the detainees in the unit were locked down. It had been about 2 weeks since anyone held in the unit had been able to shower, and we were knocking on our chuckholes to try to get the C.O.'s attention so that we might be able to shower. At this point, Lt. Fowlkes, Officer Robinson, and Officer Norbit came over to my cell. Lt. Fowlkes ordered the officers to cuff me, and after they did they put me in a visitor's booth. Once I was inside the visitor's booth with the door shut, Lt. Fowlkes began spraying O.C. spray from one of the large, black cannisters with a nozzle under the door into the visitor's booth for a continuous 10 seconds and mace filled the space. In October of 2021, I was laying down in my cell, locked down, when I heard a C.O. yell, "use the whole can!" I stood up and walked over to my door to see a crowd of 7 or 8 officers in front of the cell 3 or so cells down from mine. I was in unit 4C at the time. One officer in front of the cell was holding one of the large riot spray O.C. cannisters with the nozzle trying to spray the large cannister into the chuck hole of the cell, but was having difficulty. A second officer came up the stairs and took the cannister from the first and began spraying O.C. spray into the chuck hole. They sprayed continuously for 45 second to a minute, and it seemed like the used the whole can. It was so loud. It sounds like a fire extinguisher. They left the detainee in the cell full of mace for 3 or 5 minutes until he was taken to medical. This type of incident is common, and the spray is so strong that when someone is maced on one floor it affects not just those on their floor, but also those above and below. In addition to mace/O.C. spray, which is used as punishment and an intimidation tactic, officers use water shut-offs as a form of punishment and intimidation. In May of 2021, the water main was down, and detainees couldn't access water for 2 days. Additionally, at this time, it was common practice to routinely shut off the water for 8 hours at a time to punish detainees. To me, this is the worst place in the

world I could be. In CJC, everything gets swept under the rug. The health and safety protocols here make me fearful.




